- 3. The permit holder shall, at its expense, secure and keep in force at all times, general liability insurance in the amount of \$500,000 and provide the City with a certificate of insurance naming the City as the Certificate Holder and an additional insured.
- 4. The laws of the City of Cincinnati and State of Ohio must be observed, including but not limited to litter, noise, liquor, and conduct. Special attention should be paid to restrictions during parades outlined in Section 510-3 of the Cincinnati Municipal Code.
- 5. The City of Cincinnati will be held harmless from any claim for damage that might arise by reason of the issuance of this permit.
- 6. This permit is valid for the above date(s) and time(s) only. A copy of the permit must be in the applicant's possession at the time of the event.
